- The Government of Uganda received a loan from the International Fund for Agricultural Development (IFAD) and a Grant from the Adaptation for Smallholder Agriculture Programme (ASAP) to co-finance the Project for the Restoration of Livelihoods in the Northern Region (PRELNOR) in the districts of the Acholi Sub Region and as well as Adjumani. Part of the proceeds of this loan is to be utilized for the procurement of **50 (Fifty) 2-Wheel Walking Tractors for the project sub counties in the Districts of Gulu, Kitgum, Nwoya, Amuru, Pader, Lamwo, Agago, Omoro and Adjumani.**
- The Ministry of Local Government now invites sealed bids from eligible bidders for **the Supply and Delivery of 50 (Fifty) 2-Wheel Walking Tractors to be delivered in 25 sub counties in the above mentioned districts within 06 months.**
- Bidding will be conducted through the International Competitive Bidding (ICB) procedures as specified in the World Bank Procurement guidelines and is open to all eligible bidders as defined in the Procurement Guidelines.
